JUBOFLEX AKRIL is an acrylic sealant used for sealing aerated building materials which are subject to smaller loads.

JUBOFLEX AKRIL is an acrylic one-component sealant based on acylate dispersion. It is used to seal aerated materials located indoors.

JUBOFLEX AKRIL dispersion sealant is suitable for sealing the following aerated materials: concrete, aerated concrete, wood, ceramic tiles, less exposed gypsum boards - indoors, for repairs of smaller wall cracks, for sealing between wooden window frames and walls as well as for repairs of smaller cracks in smooth walls, on products made of solid wood, veneered and untreated chipboards, glued or panel boards prior to final surface treatment – fine polishing, application of translucent and other coats and before lacquering. It bears dilatations of up to 10 %.
