· Cement product used for grouting ceramics FUGALUX, FLX.

· Product category

FUGALUX 1 – 10 is a powder compound based on cement and used for grouting interior and exterior wall and floor tile surfaces.

· Application of the substance / the mixture

FUGALUX is a cement-based compound used for grouting interior and exterior wall and floor tile surfaces (ceramic tiles and clinkers of all types, glass- and other mosaics, slabs made of natural and artificial stone) in residential buildings, business facilities and facilities open to public. It is suitable for filling joints in width and depth of up to 10 mm, including floor tile linings in rooms with floor heating. It is distinguished by high resistance to wear and tear and good water repellency with the distinctive "drop effect" as well as long-lasting resistance against infection with wall mould.

The product is a chemical compound characterised by low content of hazardous substances. It has been verified that, apart from cement, the product does not contain any other hazardous and volatile organic substances and heavy metals.

As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.
